- Documentation requirements for processing records, risk registers, approvals, and compliance evidence.
- Aligning privacy risk assessment with enterprise risk management and digital governance frameworks.
- Practical exercise: preparing an AI-focused data protection impact assessment.

Day 4: Breach Response, Incident Management, and Regulatory Readiness

- Understanding personal data breaches in AI and GenAI environments.
- Breach scenarios involving AI platforms, model outputs, prompt leakage, unauthorized access, misclassification, and data exposure.
- Building an effective privacy breach response framework.
